

Daily Financial Bull and Bear 3X Shares

Overview

The Direxion Daily Financial Bull and Bear 3X Shares seek daily investment results, before fees and expenses, of 300%, or 300% of the inverse (or opposite), of the performance of the Russell 1000[®] Financial Services Index.

There is no guarantee the funds will meet their stated investment objective.

These leveraged ETFs seek a return that are 300% or -300% of the return of their benchmark index **for a single day.**

The funds should not be expected to provide three times or negative three times the return of the benchmark's cumulative return for periods greater than a day.

Target Index

The Russell 1000[®] Financial Services Index (RGUSFLA) is a subset of the Russell 1000[®] Index that measures the performance of the securities classified in the financial services sector of the large-capitalization U.S. equity market. **One cannot directly invest in an index.**

If these expenses were included, the expense ratio would be higher.
