

Daily MSCI South Korea Bull 3X Shares

Overview

The Direxion Daily MSCI South Korea Bull 3X Shares seek the daily investment results, before fees and expenses, of 300% of the performance of the MSCI Korea 25/50 Index (M1KR2550). **There is no guarantee that the fund will achieve its stated investment objective.**

This leveraged ETF seeks a return that is 300% of the return of its benchmark index **for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.**

Target Index

The MSCI Korea 25/50 Index (M1KR2550) is designed to measure the performance of the large- and mid-cap segments of the South Korean equity market, covering approximately 85% of the free float-adjusted market capitalization of South Korean issuers. **One cannot invest directly in an Index.**

If these expenses were included, the expense ratio would be higher.
