## Daily Latin America Bull 3X Shares

## Overview

The Direxion Daily Latin America Bull 3X Shares seeks daily investment results, before fees and expenses, of 300% of the performance of the S&P Latin America 40 Index. **There is no guarantee that the fund will achieve its stated investment objective.**

This leveraged ETF seeks a return that is 300% the return of its benchmark index **for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.**

## Target Index

The S&P Latin America 40 Index (SPTRL40N) is an equity index of issuers drawn from five major Latin American markets: Brazil, Chile, Colombia, Mexico and Perú. It is designed for investors seeking broad market exposure to highly liquid, large blue-chip companies from the Latin American markets. The Index attempts to capture 70% of the Latin American region's total market capitalization. **One cannot directly invest in an index.**
