

Daily Mid Cap Bull and Bear 3X Shares

Overview

The Direxion Daily Mid Cap Bull and Bear 3X Shares seek daily investment results, before fees and expenses, of 300%, or 300% of the inverse (or opposite), of the performance of the S&P MidCap 400® Index. **There is no guarantee the funds will meet their stated investment objective.**

These leveraged ETFs seek a return that is 300% or -300% of the return of their benchmark index **for a single day. The funds should not be expected to provide three times or negative three times the return of the benchmark's cumulative return for periods greater than a day.**

Target Index

The S&P Mid Cap 400® Index (SPTRMDCP) measures the performance of 400 mid-sized companies in the United States. The Index is a free-float adjusted market capitalization-weighted index composed of liquid common stocks. **One cannot directly invest in an index.**

If these expenses were included, the expense ratio would be higher.
