

## Daily S&P 500 Bull 2X Shares

### Overview

The Direxion Daily S&P 500<sup>®</sup> Bull 2X Shares seeks daily investment results, before fees and expenses, of 200% of the performance of the S&P 500<sup>®</sup> Index. **There is no guarantee the fund will meet its stated investment objective.**

This leveraged ETF seeks a return that is 200% the return of its benchmark index **for a single day. The fund should not be expected to provide two times the return of the benchmark's cumulative return for periods greater than a day.**

### Target Index

Standard & Poor's<sup>®</sup> selects the stocks comprising the S&P 500<sup>®</sup> Index (SPXT) on the basis of market capitalization, financial viability of the company and the public float, liquidity and price of a company's shares outstanding. The Index is a float-adjusted, market capitalization-weighted index. **One cannot directly invest in an index.**

If these expenses were included, the expense ratio would be higher. Rafferty has voluntarily agreed to waive all or a portion of its investment advisory fee and/or reimburse certain expenses of the Fund. Rafferty may withdraw this expense limitation at any time and may not recoup any voluntarily waived fees and/or reimbursed expenses.
